Location

Kingsbridge is a market town in the South Hams district of Devon. It has a population of approximately 6,100 people which is often increased by tourist numbers during the summer months given its proximity to Kingsbridge Estuary. The property is situated on Duncombe Street, a predominately residential area albeit with Kingsbridge Fire Station being located broadly opposite to the building. At the western end of the road it connects to Fore Street which is the main retailing pitch for the town centre.

Description

The property comprises a two storey, commercial building of brick and block construction at ground floor level and a wooden frame with steel cladding on first floor. There is a car port at the side of the building as well as a driveway at the front of the property. The ground floor of the property provides a former chapel of rest. The first floor is accessed by an external staircase at the rear and comprises a workshop space. We understand this accommodation has not been used for a number of years.


