Weston-super-Mare

Weston-super-Mare is a significant seaside town in North Somerset, with a population of around 85,000 people. The town sits only 20 miles south west of Bristol and represents the strongest coastal centre in the region. The town is well served with transport communications, with junction 21 of the M5 motorway being approximately 4 miles from the town centre, a mainline railway station, and Bristol International Airport approximately 15 miles north east.

Dolphin Square, located a short distance from the seafront, is the town's prime leisure district and home to the main cinema, climbing and gym facilities, along with supporting bars and restaurants. Adjacent is a 380 space car park, a modern Premier Inn hotel and to the rear, the Town Hall with police and council offices.



Key tenants include Cineworld, Nandos, Clip 'N' Climb, Anytime Fitness and Costa along with a significant All Star Sports Bar featuring bowling, escape rooms, karaoke, and other competitive leisure facilities alongside a full food and drink offering.




