The property comprises a detached industrial warehouse with ancillary, workshop and storage to the rear linked to an end of terrace former residential building converted to offices. The warehouse is configured as a 3 bay workshop with office, reception, WCs and ancillary storage. Annexed to the rear of the building is a linked warehouse used for storage. Externally there is provision for customer parking at the front and a large self-contained yard area to the rear.


